

Citi PremierMiles - Agoda Tactical Promotion 2015

“Promotion” refers to the Citi PremierMiles – Agoda Tactical promotion.

1. This promotion is valid for bookings made between 1 January and 28 February 2015 and for stay between 1 January and 31 March 2015.
2. This promotion is valid only for Citi PremierMiles Visa Cards and Citi PremierMiles American Express® Cards issued in Singapore, including supplementary card(s).
3. Citi PremierMiles Visa and Citi PremierMiles American Express cardmembers of Citibank Singapore (“Cardmember”) must make booking via the dedicated landing page at www.agoda.com/citimiles and must settle payment with their Citibank PremierMiles Visa Card or Citi PremierMiles American Express® Card to be entitled to bonus 6 Citi Miles per S\$1 spent.
4. In addition to what you currently earn on the card (“base earn rate” as defined in point 5 below), you will be entitled to an additional 6 Citi Miles (bonus earn rate).
5. *The base earn rate will be credited upon transaction approval. Base earn rates are as follows:
 - a. 1.2 Citi Miles per S\$1 spend on Local Spend on Citi PremierMiles Visa Card
 - b. 1.4 Citi Miles per S\$1 spend on Local Spend on Citi PremierMiles American Express® Card
 - c. 2.0 Citi Miles per S\$1 spend on Overseas Spend on Citi PremierMiles Visa Card or Citi PremierMiles American Express® Card
6. Local Spend refers to retail transactions denominated in Singapore Dollars.
7. Overseas Spend refers to retail transactions denominated in currency other than Singapore Dollars.
8. ^The bonus earn rate of 6 Citi Miles will be credited to Cardmember’s credit card account within two months of Cardmember’s departure from hotel.
9. For bookings made after 28 February 2015 and stay is completed by 1 January 2016, Cardmember will be entitled to another bonus earn rate of 4 Citi Miles. These bonus miles will be credited to Cardmember’s credit card account within 2 months of Cardmember’s departure from hotel.
